2. The Criteria for selection shall be as per O.M. No. 1/6//83-PER(Vol.II)Pt.(a)/143 dated 14/01/2019 issued by the Personnel Department and approved by the Revenue Department is enclosed as **Annexure 'C'**.
3. The Syllabus for eligible candidate for written test for all the posts is enclosed as **Annexure 'D'**
4. The Candidates already working in the Government, local self Government, Semi-Government, autonomous bodies or establishment, or any other department/ body establishment or institution being an instrumentality of the Government should send their applications through proper channel only on or before last date of submission of the application.
